The following Promotion is intended for the 50 United States, the D.C. and U.S territories.

OFFICIAL RULES

- 1. How to Enter:** Beginning at 10:00 a.m. Eastern Time (“ET”) on June 17, 2025 until 11:59 p.m. ET on June 17, 2025 (the “Promotion Period”), donors who make a gift of \$250 or more on 06/17/25 will be automatically entered into the Cure Blindness Project Cataract Awareness Month Promotion (the “Promotion”) by making an online donation which qualifies for the Cataract Awareness Month Give Away.
- 2. Eligibility:** This Promotion is open only to residents of the 50 United States and D.C., and US territories, who are 18 years of age or older as of the Promotion start date. Employees and members of their households, and current members of the Board of Directors, whether or not related, and immediate families (spouses, parents, siblings, children and each of their respective spouses) of the Promotion Entities (as defined below) and their respective parent companies, subsidiaries, and affiliates, and their advertising and promotion agencies and all local sponsors are not eligible. Void where prohibited.
- 3. When you enter the Promotion on the Website, you may be asked to consent to receive promotional emails and reminders for upcoming promotions and information about Cure Blindness Project. Consenting to receive such emails is optional and does not have to be agreed to in order to be eligible to enter the Promotion and does not improve your chances of winning.
- 4. Limitations of Liability:** Cure Blindness Project and their respective officers, directors, employees and agents, and any and all Internet servers and access provider(s) (collectively, “Released Parties”) are not responsible for: any incorrect or inaccurate Entry information; human error; technical malfunctions; failures, omissions, interruption, deletion, or defect of any telephone network, computer online systems, computer equipment, server providers, or software, including any injury or damage to your or any other person’s computer relating to or resulting from participation in this Promotion; inability to access the Websites; theft, tampering, destruction, or unauthorized access to, or alteration of Entries; Entries that are processed late or incorrectly or are incomplete or lost due to computer or electronic malfunction or traffic congestion on the Internet or at any website; printing, typographical, human or other errors; and any Entries which are late, lost, incomplete, delayed, misdirected, stolen, mutilated, illegible inaccurate, or any combination thereof. Entries are considered only upon receipt. Proof of online submission is not considered proof of delivery or receipt. Cure Blindness Project reserves the right to select the prospective Prize Winner(s) in a random drawing format that shall be determined by Cure Blindness Project. By entering, you agree to release, discharge, indemnify and hold harmless the Released Parties from and against all claims and damages or liability arising in connection with your participation and/or entry in the Promotion and/or your receipt or use of any Prize (as defined herein) awarded in this Promotion (including any travel or activity related thereto) or due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or

in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in any Promotion-related activity or participation in this Promotion. If by reason of a printing or other error, more prizes are claimed than the number set forth in these rules, all persons making purportedly valid claims will be included in a random drawing to award the advertised number of prizes available in the prize category in question. No more than the advertised number of prizes will be awarded.

5. **How Recipients will be Determined:** ALL "THANK YOU GIFT" Recipients will be selected in a random drawing from among all eligible Entries received during the Promotion Period on approximately July 1, 2025. Donors randomly selected for the "Thank You Gift" will be contacted either by phone or email on July 1, 2025. Cure Blindness Project's decisions with respect to this promotion, these Official Rules, and all other matters pertaining to the Promotion shall be final and binding. Any donor who cannot be contacted within 10 days of receipt of notice via email by Cure Blindness Project, will have their "Thank You Gift" forfeited and Cure Blindness Project shall randomly select another qualified donor to receive the Gift.
6. **Conditions of Entry:** Entry materials that have been tampered with or altered are void. If, in Cure Blindness Project's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Promotion, or if computer viruses, bugs, unauthorized intervention, fraud, or technical difficulties or other failures compromise, corrupt, or affect the administration, integrity, security, fairness, or proper conduct of the Promotion, Cure Blindness Project reserves the right, at its sole discretion, to disqualify any individual who tampers with the entry process and void any Entries submitted fraudulently, to modify, suspend, or terminate the Promotion, or to conduct a random drawing to award the Prize using all eligible, non-suspect Entries received as of the termination date or as otherwise deemed fair and appropriate by Cure Blindness Project. Should the Promotion be terminated prior to the stated expiration date, notice will be posted on the Website. In the event of a dispute as to the identity of the prospective Prize Winner based on an email address, the winning Entry will be declared made by the Authorized Account Holder of the email address submitted at time of Entry.

Estimated value of Prize is \$150.00. All donors may choose to opt-out of the drawing at the time of the online donation. Donors who are selected to receive a "Thank You Gift", are ineligible to win a second "Thank you Gift" during this Cataract Awareness Month promotion.

All costs, taxes, fees, and expenses associated with any element of the Prize not specifically addressed above are the sole responsibility of the Recipient. All federal, state, and local taxes on the Prize are the Recipient's responsibility. The Recipient will be issued a receipt for the actual value of the Gift. The specifics of all aforementioned elements of the Gift in the Promotion shall be solely determined by Cure Blindness Project. Some restrictions may apply. Gift cannot be transferred, substituted or redeemed for cash.

8. **Disputes/Governing Law:** All issues and questions concerning the construction, validity, interpretation and enforceability of these rules, or the rights and obligations of any entrant or the Promotion Entities in connection with the Promotion, shall be governed by and construed in accordance with the laws of the State of Vermont without giving effect to any choice of law or conflict of law rules or provisions which would cause the application of the laws of any jurisdiction other than the State of Vermont. Any action or litigation concerning this Agreement shall take place exclusively in the federal or state courts sitting in Vermont. Any and all disputes, claims, and causes of action arising out of or in connection with this Promotion, shall be resolved individually, without resort to any form of class action. You agree to service of process by mail or other method acceptable under the laws of the State of Vermont.
